TERMS/CONDITIONS:

I/We hereby agree to abide by the following terms and conditions:

1. The Vendor agrees to hold harmless and indemnify the Flagship Niagara League ("League") for any injury or loss that might arise or come to the Vendor or his/her employees or his/her goods or any third party from any cause whatsoever while said premises are being occupied under this agreement.
2. The League will NOT provide insurance. All insurance must be placed and paid for by the Vendor. I/We hereby relieve League of the event of all responsibility in connection with the safekeeping of our property while said properties are at this event. Vendor will provide copy of certificate of insurance that names the League as additional insured satisfactory to the League.
3. The Vendor agrees to display and/or sell only those items which have been listed on the contract, and agrees to remove from the display all articles or signs objectionable to the League. The League does not guarantee product exclusivity to any vendor. Vendor agrees to abide by all sponsorship and pricing requirements of the League.
4. The Vendor must acquire all necessary permits or licenses and comply with all Authority, City of Erie, County of Erie, State and Federal laws and regulations.
5. The League will NOT provide tables or chairs. Vendors will display outdoors and will provide own tables, tarps, etc. No early tear downs.
6. Vendor is responsible for proper waste removal.
7. Payment and insurance certificate(s) must accompany application. Any application received without payment and certificate of insurance will be returned.
8. Vendors wishing to set-up the evening prior to the event will be allowed to retain space and leave tables and tarps, etc.; however, merchandise must be secured at the Vendor's own risk.
9. Vendors must supply the League with copies of all applicable permits and licenses, including, but not limited to: sales tax ID, health department permits.
10. The League provides electric service as it exists at Dobbins Landing.
11. Vendors agree to placement of vending space as determined by the League.
12. The League reserves the right to terminate this agreement for any reason and at any time.
